2017 – 2019 GENERAL BY-LAWS UPDATE NO. 2 – DC / PC AMENDMENTS

THE FOLLOWING AMENDMENTS TO THE GBLB ARE THE RESULT OF DOMINION COMMAND ELIMINATING COMPULSORY INITIATIONS OF ALL NEW MEMBERS AND THUS NECESSITATING AMENDMENTS TO OUR GENERAL BY-LAWS PURSUANT TO SECTION 1301. (2) GBLO. THESE AMENDMENTS ARE AUTOMATICALLY INCORPORATED IN THESE BY-LAWS WITHOUT THE NEED FOR FURTHER APPROVAL.

THE FOLLOWING AMENDMENTS TO THE GBLO (GENERAL BY-LAWS OF THE ONTARIO PROVINCIAL COMMAND) AND GBLB (THE GENERAL BY-LAWS FOR BRANCHES OF THE ONTARIO PROVINCIAL COMMAND) WERE PASSED AT THE MOST RECENT MEETING OF THE PROVINCIAL EXECUTIVE COUNCIL ON NOVEMBER 18TH, 2017 AND WERE APPROVED BY THE DOMINION COMMAND CONSTITUTION AND LAWS COMMITTEE PURSUANT TO SECTION 512. A. OF THE GENERAL BY-LAWS EFFECTIVE ON THE 19TH OF DECEMBER, 2017.
